2. **The cost of Application:** The cost of application form (*Non-refundable*) is Rs. 1000/- One Thousand (***Rs. 250/- Two Hundred & Fifty; for EBC/SC/ST candidates***). The application-form completed in all respect along-with requisite application fee (*Non-refundable*), must be accompanied with Demand Draft, drawn in favor of **Director, IGIMS, Patna-14**, payable at Patna. **Application/s not accompanying the cost of application shall be rejected.**
3. **After selection and issue of appointment letter, discharge/relieving certificate after resignation from the previous employer, is essential before joining.**
4. In addition to Pay, NPA (*For Medical candidate only*) and other allowances will be admissible as per rule for regular appointment.
5. The posts are **non-practicing** and private practice of any kind, direct or in-direct, including laboratory practices is strictly prohibited. If found indulging in such practices, appointment of the candidate shall be terminated.
6. Stay in the campus is compulsory, if accommodation is not provided, HRA is admissible as per rule.
7. Reservation point and relaxation in upper age limit will be applicable as per rule of Govt. of Bihar. **Reservation benefit shall be applicable to permanent resident of Bihar only and the applicant from out-side the State of Bihar will not be entitled for the reservation. Physically-Handicapped candidate will be given the benefit of reservation and relaxation as per rule of Govt. of Bihar. Person working In Govt. Institution shall be given relaxation as per rule.**

2. For BC/EBC candidate: Candidates must attach certificate valid for the posts as prescribed by the Government of Bihar which mentions that the candidate does not belong to Creamy Layer (form -X).
3. EWS certificate should have been issued after 01-04-2024 till date of interview.
4. FOR SC, ST, EWS & PWD – certificates should be issued by authorities prescribed by Govt. of Bihar.
8. Any matter which is not mentioned or not clear regarding reservations rule, will be guided by reservation rule Dept. of General Administration, Govt. of Bihar.
9. Candidates who are employed must apply through proper channel. In case of advance application "No Objection Certificate" mandatorily to be submitted at the time of interview, otherwise their candidature shall not be considered for selection. No extension of time for submission of N.O.C. will be granted.

Research experience after obtaining the essentials qualifications should be evidenced by project, indexed publication in concerned subject, (preferably Pub Med) , Research patent, Extra Mural / Intra Mural research Project, book chapter & guiding the M.D.S / Ph.D students in the capacity of guide / co-guide.
