Sub: Regarding engagement on the post of Medical Physicist in the department of nuclear medicine on Contractual Basis at IGIMS, Patna for a period of eleven months.

Sir,

With reference to your application for the post of Medical Physicist in the department of nuclear medicine on Contractual Basis at IGIMS, Patna for a period of eleven months against Advt. No.- 01/Walk-in-interview-Medical Physicist/IGIMS/Estt./2022, IGIMS Patna-14 and interview held on 31-01-2022 and as authorized by the Board of Governors, under Res. No 94/1427 (A), the undersigned is directed by the competent authority to inform you that you have been selected to the post of Medical Physicist in the department of nuclear medicine on Contractual Basis at IGIMS, Patna for engagement on contract basis initially for a period of eleven months with effect from the date you assume the charge to the said post on remuneration Rs. 75000/-(Rupees Seventy five thousand only) per month and no encashment during the contract period on the following terms and condition:-

- 1. In respect to conduct, discipline and penalties you will be governed by the rule of the institute.
- 2. No other facilities as admissible to Govt. servant shall be given expect above consolidated amount.
- 3. The period of Contract appointment will initially be for 11 (Eleven) months, thereafter year wise extension will be given on the basis of its need & performance which will be discretion of the competent authority.
- 4. Other facilities i.e. Leave, Medical (In-door, Out –door facility available at this Institute) etc. will be guided by the rules of the Institute. No Medical Bill be reimbursed.
- 5. In case of any misconduct, like poor punctually, habitual negligence in duty, disobedience of proper order, willful delay in disposal of work, indulgence in private practice/trade/business and poor performance etc., the contract appointment can be terminated at any time without notice and assigning any reason.
- 6. On completion of the period of contract engagement it will automatically be treated as ended and no order in this regard shall be required to be issued separately.
- 7. Your services shall not be transferable.
- 8. Such engagement can be terminated by Institute by given one month prior notice.
- 9. If you violate any terms this engagement letter shall automatically be treated as terminated.

  - (a) Medical Fitness from Institute Medical Board.
  - (b) Self attested copies of certificates your acceptance immediately on notarized paper and if accepted, please join the post on or before 15-02-2022.
