Physically-Handicapped candidate will be given the benefit of reservation and relaxation as per rule of Govt. of Bihar. Also In-case of unavailability of eligible FEMALE candidate (Where applicable) MALE candidate of same category for respective Department, can be considered. In case of unavailability of eligible reserved category candidate, suitable candidate from other category as provided in the rule can be appointed on adhoc basis for a period of one year or till tenure appointment through open advertisement is made (whichever is earlier)

- A. A postgraduate Medical Degree viz. MD in Emergency Medicine, from a recognized University/Institute, For the post of Medical Emergency in case of non-availability of candidate with Emergency Medicine qualification, candidates with M.D. Medicine will be considered for theses posts, and interview/examination will be held separately for this post. For which separate application is required to be submitted with separate fee.

Candidates employed in Government/Semi Government Department or any other employer must submit their application along-with "No Objection Certificate" issued by the employer, at the time of interview, otherwise, they will not be considered for selection. In case of not in employment, candidate must submit in writing that they are neither employed in

any organization nor doing any course anywhere.

SC/ST candidate must attach their Caste Certificate issued by Circle Officer of respective District/Circle of Bihar along-with application form. EBC/BC candidate must attach their Caste Certificate along-with Certificate of exemption from Creamy 3. <u>Layer in form -X</u> duly issued by the Circle Officer of respective District/Circle of Bihar along-with application form. EWS candidate must attach their EWS Certificate issued by Circle Officer of respective District/Circle of Bihar along-with

application form if claimed for reservation.

Handicapped person/candidate will be given the benefit of reservation as per rule of Govt. of Bihar. Person working in Govt. Institution shall be given relaxation as per rule. Number of vacancy, in each department may increase or decrease. In-case of unavailability of eligible FEMALE candidate (Where applicable) MALE candidate of same category for respective Department, can be considered. In case of unavailability of eligible reserved category candidate, suitable candidate from other category as provided in the rule can be appointed on adhoc basis for a period of one year or till tenure appointment through open advertisement is made (whichever is earlier)
