**Note:** (1) Reservation benefit shall be applicable to Bihar State domicile candidate only and the applicant from outside the State of Bihar will not be entitled for the benefit of reservation. Physical-Handicapped candidate will be given the benefit of reservation and relaxation as per rule of Govt. of Bihar.

**Pay Scale:**

Rs. 35025/- during 1<sup>st</sup> year, Rs. 35888/- 2<sup>nd</sup> year and Rs.36763/- 3<sup>rd</sup> year inclusive of NPA plus usual allowances as admissible for Senior Residents in this Institute.

**Approx Total Emolument comes as on today:** Rs.53300/- during 1<sup>st</sup> year, Rs.54558/- 2<sup>nd</sup> year and Rs.55826/- 3<sup>rd</sup> year.

**Upper Age Limit:**

35 Years as on: **31-01-2014** (Relaxation as per State Govt. Rule, i.e., 5 years for SC/ST, 03 Years of MBC/BC and 03 years for all categories of Female candidate).

**Essential Qualification & Experience for Senior Resident:**

1. A Medical qualification as included in schedule I & II of MCI Act.
2. Recognized P.G. qualification of MD/MS in specialization concerned or allied Surgical/Medical speciality.
3. **The candidate must be registered with Central/State Medical Council.**

The Qualification prescribed is minimum requirement and the same does not automatically make candidates eligible for interview. Based on bio-data, the Screening Committee of the Institute, will shortlist candidate/s for interview. Candidate/s who will be called for interview will have to produce all relevant original documents, in proof of details furnished in their application at the time of interview.

## GENERAL INSTRUCTIONS

1. Application form can be downloaded from our website [http: www.igims.org](http://www.igims.org). The cost of application form is Rs. 500/- (Rupees Five Hundred) and Rs.125/- (One Hundred Twenty Five) for SC/ST candidates payable at Patna in the form of Demand Draft in favour of Director, IGIMS, Patna. **Those who downloads the application form from Institute website, shall have to submit a demand draft of Rs. 500/- or Rs.125/- (as applicable) in favour of Director, IGIMS, payable at Patna.**
2. Candidate's employed in Government/Semi Government department or any other employer must apply through proper channel. In case-of advance application "**No Objection Certificate**" issued by employer must be submitted at the time of interview, otherwise they will not be considered for selection In case of not in employment candidate must submit in writing that they are not employed at any organization.
3. **SC/ST** candidate must attach their caste certificate issued by **Circle Officer** of respective District/Circle along with application form. **MBC & BC** candidate must attach their Caste Certificate along-with Certificate for exemption from creamy layer duly issued by the **Circle Officer** of respective District/Circle along-with application form if claimed for reservation.
4. Reservation point and Relaxation in upper age limit will be applicable as per rule of Govt. of Bihar. **Benefit of reservation will be given to Bihar State domicile only and the applicant out-side the State of Bihar will not be entitled for the benefit of reservation. Handicapped person/candidate will be given the benefit of reservation as per rule of Govt. of Bihar. Persons working in Govt. Institution shall be given relaxation as per rule.**
5. **Number of vacancy, in each department may increase or decrease.**
6. In addition to Pay + NPA, other allowances will be admissible as per Institute rule.
7. **The posts are non-practicing private practice of any kind, direct or indirect, including laboratory is strictly prohibited and if found indulging in such private practice, appointment of candidate shall be terminated.**
8. **Stay in the campus is compulsory, if accommodation is provided.**
9. **Mere selection by the Selection Committee does not give right of appointment to the candidate. The Institute reserves the right of appointment of the candidate/s recommended by the Selection Committee.**
10. **The Selection Committee's panel will be valid for 06 (Six) months only.**
11. The applications completed in all respect along with self attested photocopies of certificates/testimonials (**Proof of Age, Qualification, Experience, Registration with MCI/State Medical Council**) and recent passport size photograph as well as requisite fee should reach by registered/speed post/Courier to the Director, IGIMS, Sheikhpura, Patna-14 (Bihar) on or before: **15-02-2014 till 01:30 P.M.** "**Institute shall not be responsible for any lapses or delay by the Postal Department or Courier Agency**". The incomplete application and application received after last date will not be accepted.
12. **Candidate must write Advt. No. and name of the post and department, on the top of the envelope in bold letter.**
13. **The Director of the Institute reserves the right to reject/accept any or all the applications without assigning any reason and cancel the advertisement.**
14. Canvassing in any form will be a disqualification.
15. Separate application duly completed in all respect for each department/post should be submitted.
16. No TA/DA is admissible for attending the Interview.
17. A declaration that whether they have filled up declaration form and appeared before the M.C.I. Team for the year 2013-14, for any Medical College or not, should be submitted.
