  - (ii) Production of the following certificate, in original.
    - (a) If in employment you will have to submit proper discharge certificate(Relieving order) from your present employer and if you are not in any employment, you will

- (a) have to submit an affidavit to that effect, failing which your joining will not be accepted and the appointment will stand cancelled.
  - (b) Certificate in support of your qualifications and experience making you eligible for this post.
  - (c) Certificates of registration with its up to date validity from appropriate Registration Council.
