5. Other conditions of service will be as are provided for in the rules, the regulation, etc., of the Institute and as amended from time to time.

7. You are liable to serve in any of the Rural Health Centres and Urban Health Centres of the Institute, if so required.

If you do not join the post by the stipulated date, this offer of appointment is to be treated as cancelled/withdrawn.
