Officers from any of the Central organised Accounts services holding analogous posts or posts in the pay scale of Rs. 10000-325-15200 (Pre-revised), PB-3 Rs. 15600-39100-+GP Rs. 6600 (Revised) with 5 years of regular service in the grade.

In the event of not finding suitable officers from the organised Accounts Services, officers in the Finance and Accounts Departments of Central/State Government Statutory/Autonomous Bodies or Public Sector undertaking holding the posts of the level specified above shall be considered.
