All other terms and conditions will be as per Memo No: V-16020/28/2017-INI-I(Pt.), Government of India, Ministry of Health and Family Welfare, dated 23rd August 2018, which is being followed in AIIMS, New Delhi vide no. F. 14-3/69(99)-Estt.-I dt. 19.09.2018 & dt. 07.12.2018.

The reimbursement of Learning Resources allowance will include the following:

- 1) Membership fee of Professional Societies.
- 2) Subscription of Scientific Journals.
- 3) Purchase of books & journals.
- 4) Equipments used for research purpose such as Desktops, Laptops, additional portable hard disk, Pen drive, CDs & other computer peripherals.
- 5) Repair/Replacement expenses of such equipments.
- 6) Photography equipments like photography camera and their peripherals.
- 7) Smart Phones with e-mail features.
- 8) Transparencies, slides and similar resource material required to enhance the learning.
- 9) Other conditions as mentioned in the AIIMS New Delhi Memo No. F. 14-3/69(99)-Estt-I dt.07/12/2018 and further amendments.

2. In the matter of Leave Travel concession, Telephone and Newspaper Allowance and other benefits, order will be issued in next financial year after budgetary provision.
