7. That, the minimum height of stack for exhaust emission to be provided with D.G set shall be 1.0 meter more than the height of the building where it is installed.

8. That, the unit shall maintain Online Stack Emission Monitoring System.

9. That, the unit shall submit Environmental Statement by Sept. every year; 10.

That, tree plantation shall be done in space available in the complex; 11.

That, the operator shall comply all the conditions as imposed in the Authorisation under the Bio-medical Waste Management Rules, 2016

12. That, the unit shall submit Annual Report in Form -IV under the Bio-Medical Waste Management Rules, 2016 to the Board within 30th June every year:
