Eligibility Criteria:

1. The Foreign Medical Graduates who are applying must be provisionally registered with National Medical Commission / State Medical Council.

Reservation of Posts :

1. Reservation point and relaxation in upper age limit will be applicable as per rule of Govt. of Bihar. Reservation benefit shall be applicable to permanent resident of Bihar only and the applicant from out-side the State of Bihar will not be entitled for the reservation. Physically-Handicapped candidate will be given the benefit of reservation and relaxation as per rule of Govt. of Bihar.
2. The reservation for BC/EBC/SC/ST/EWS/WBC & Female candidates is as per Bihar Govt. rules.
3. For BC/EBC candidate: Candidates must attach certificate valid for the posts as prescribed by the Government of Bihar which mentions that the candidate does not belong to Creamy Layer(form -X). Date of issue of certificate should not be earlier than 01 year from the last date of application.
4. EWS certificate should have been issued after 01-04-2024 till date of interview.
5. FOR SC, ST, EWS & PWD – certificates should be issued by authorities prescribed by Govt. of Bihar.
Any matter which is not mentioned or not clear regarding reservations rule, will be guided by reservation rule Dept. of General Administration, Govt. of Bihar.

In-case of unavailability of eligible FEMALE candidate (Where applicable) MALE candidate may be considered & In-case of unavailability of eligible EWS candidate (Where applicable) Un-reserved candidate, may be considered:

Self-attested copies enclosed with application form : Date of Birth Certificate (10th Certificate), Intermediate/10+2 Certificate/ All MBBS Mark-sheets, Degree Certificate, FMG Score Card, Caste / Non Creamy Layer & Residential certificate (EWS/BC/EBC/SC/ST), PWD Certificate and provisional BCMR/NMC registration certificate.
