#### Resolution:

As per departmental proceeding against Dr. Rajesh Kumar Singh, Professor & the then Head, RCC Department, now Head – Radiation Oncology, State Cancer Institute submitted by Enquiry Officer Dr. Kaushal Kishore, IAS, Dr. Rajesh Kumar Singh knowingly prescribed the Medicine of M/s Ayon Health Care Limited, Patna of which his wife Smt. Ranjana Singh was one of the Director, suppressing the fact from the office of the IGIMS, Patna. Further, he also suppressed that his wife was one of the Director of the M/s Ayon Health Care Limited, Patna and has thereby benefitted the company by prescribing the drugs for the treatment of cancer patients attending the IGIMS, RCC OPD and the admitted patients in the ward.

Any violation of the code of conduct or breach of any rules or regulations of the Institute by any employee shall constitute an act of indiscipline and shall make him liable for disciplinary action against him.

As per AIIMS, N. Delhi, BOG is authorized for any penalty to Faculty Members and Group – A officers.

BOG after discussion imposes penalty on Dr. Rajesh Kumar Singh, Professor & Head – Department of Radiation Oncology, State Cancer Institute as reduction to a lower stage in the time-scale of pay by one stage for a period not exceeding three years, without cumulative effect and not adversely affecting his pension as per CCS / CCA Rules – 11(Minor Penalties, iii – a) under Part – V.
