Confirmation of the minutes of 94th meeting, 94th (Extended) meeting and 95th (Extraordinary) meeting of B.O.G.

Resolution : Confirm with following observations :-

Item No :- 93/1412

A committee with a member from Institute side and one from Department of Health, Govt. of Bihar is to be constituted to raid the clinics run by the Doctors of the institute to prevent Private Practice, in addition, the technical staff of the institute who as per the IGIMS Rules cannot perform duty outside the institute campus, should also be verified by this committee. Action taken against erring staff of the institute by the Director will be placed before the next BOG Meeting.

Item No. 94/1419 (Item No. 15/03)

The current status of DAV School is to be maintained. The Management of the DAV School and that of the institute are different and therefore, the land belonging to the institute should not be transferred either on permanent basis or on lease to DAV Management. It was also noted that the institute is already having shortage of space.

Item No. 94/1420

Regarding awarding Gold Medal to the topper in Ophthalmology, decision of Standing Academic Committee held on 04-02-2015 was followed as per guidelines of AIIMS, New Delhi.

<u>Resolution</u>: Though it is necessary to obtain the donations for the Corpus Fund of the Institute, the guidelines should not be misused for narrow self-interests. Director will comeup with detail guidelines and place them before next BOG meeting.

Item No.94/1441 (ix) (other items discussed and approved with the approval of Chairman)

In regularization of Contract employees, guidelines of General Administration Department (GAD), Govt. of Bihar and Hon'ble Supreme Court order are to be followed.

Director, IGIMS, Patna is authorised to constitute a committee comprising one member of Health Department, Govt. of Bihar and one from IGIMS, Patna to enquire into the provisions of reservation rules and their application in promotion/appointment/contract appointment as raised by Dr. Santosh Kumar, Member of BOG.

(D) Director stated that in case of AIMS, the Director is empowered for procurement of equipments and instruments up to 50 lakh Rupees, Standing Finance Committee will approve procurement of equipments and instruments above Fifty Lakhs up to 5 crores Rupees and procurement of equipments and instruments worth more than 5 crores Rupees will only be placed before the BOG meeting.

BOG resolved to adopt the same guidelines in the institute as well. Accordingly Director and Standing Finance Committee are empowered for procurement of equipments and instruments. It will be the combined responsibility of the Director and the Standing Finance Committee that all due procedures are followed and procurement is done in fair and transparent manner. Full payment to the supplier of equipments and instruments will be made only after the concerned Head of the Department gives a certificate to the effect that the instrument complies with tender specifications, instrument is installed and in good working condition.

Only after obtaining the approval from the Government, recruitment against sanctioned and vacant posts will be done as per the laid down procedures, rules and regulations.
