In exercise of the power conferred by the 24(j) and 35(4) of NMC Act, 2019, the approval of the UGMEB, NMC is hereby conveyed for grant of *Continuation of Recognition of MBBS degree granted on or after March, 2022 by Indira Gandhi Institute of Medical Sciences (Deemed University), Patna in respect of the students being trained at Indira Gandhi Institute of Medical Sciences, Patna, Bihar* with sanctioned annual intake of 100 MBBS students under the following terms & conditions, as contained in the Gazette Notification No. MCI- 34(41)/2010-Med./3491, dated 16th April, 2010 titled "Establishment of Medical College Regulations. (Amendment), 2010:

- (i) *The recognition so being granted herein, shall be valid for a maximum period of the 05 (five) years from the date of issue, upon which it shall have to be renewed.*
- (ii) *The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.*
- (iii) *Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute.*

2. This approval for Continuation of Recognition (100 seats) is granted subject to applicability of amendments in MCI/NMC Regulations from time to time.
