Sub: Recognition/Approval of Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna for the award of MBBS degree (100 seats) by Indira Gandhi Institute of Medical Sciences, Patna u/s 11(2) of the IMC Act, 1956.

Sir,

I am directed to inform you that an assessment to verify the compliance submitted by the college authorities of Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna, on the deficiencies pointed out in the assessment report (2<sup>nd</sup> & 3<sup>rd</sup> March, 2016) with regard to recognition /approval of the college for the award of MBBS degree (100 seats) granted by Indira Gandhi Institute of Medical Sciences, Patna u/s 11(2) of the IMC Act, 1956 was carried out by the Council Assessors on 25<sup>th</sup> April, 2016. The compliance verification assessment report (25<sup>th</sup> April, 2016) along with the previous assessment report (2<sup>nd</sup> & 3<sup>rd</sup> March, 2016) was considered by the Executive Committee and subsequently by the General Body of this Council at its meeting held on 22.11.2016. The Council approved the following recommendations of the Executive Committee:-

The Executive Committee of the Council considered the compliance verification assessment report (25<sup>th</sup> April, 2016) alongwith previous assessment report (2<sup>nd</sup> & 3<sup>rd</sup> March, 2016) and decided to recommend to the Central Government for recognition/approval of Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna for the award of MBBS degree (100 seats) by Indira Gandhi Institute of Medical Sciences, Patna u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16<sup>th</sup> April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute.

In view of above, you are, therefore, requested to issue necessary notification at the earliest recognizing Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna for the award of MBBS degree when granted on or after Jan., 2016 by Indira Gandhi Institute of Medical Sciences, Patna.

A copy of the assessment report is enclosed herewith.
