Any failure to submit the information within this time limit would be construed that the admissions in the College were not in accordance with the statutory requirements, thereby enabling the Council to proceed in accordance with law against the College.

I am further directed to inform that you and your institution are fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material, etc. throughout the academic year, as stipulated in Regulation of Medical Council of India.
