DETAILS & TERMS & CONDITIONS OF JUNIOR RESIDENTS (NON-ACADEMIC) ONE YEAR TENURE POST

Eligibility Criteria:

- 1. The candidates should have passed MBBS including completion of Internship or equivalent degree recognized by NMC.
- 2. Only those candidates who have appeared in NEET PG in 2024 but did not get admission to any Medical College in accordance to rules & regulations of Govt. of Bihar will be considered.
- 3. For all eligible candidates, maximum one term is allowed. If anyone joins and leaves at any time it will be counted as one term irrespective of duration of work done.
- 4. Work experience in Armed Forces, Central/State Health Services and Private Nursing Homes will be taken as equivalent to Junior Residency (Non- Academic).

Reservation:

- 1. The reservation for BC/EBC/SC/ST/EWS, Female & Reservation for Disability Quota / Wards of Freedom Fighters etc. as per Govt. of Bihar.
- 2. For BC/EBC candidate: Candidates must attach certificate valid for the post in format prescribed by the Government of Bihar which mentions that the candidate does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 01 year from the date of advertisement.
- 3. EWS certificate for Junior Residency should have been issued after 01-04-2024.
- 4. FOR SC, ST, EWS & PWD certificate should be issued by authorities prescribed by Govt. of Bihar.

In-case of unavailability of eligible FEMALE candidate (Where applicable) MALE candidate may be considered & In-case of unavailability of eligible EWS candidate (Where applicable) Un-reserved candidate for respective Department, may be considered:

- 2. Self-attested copies enclosed with application form: Date of Birth Certificate (10th Certificate), All MBBS Mark-sheets, Degree Certificate, Internship Completion Certificate, NEET-PG Score Card, Caste certificate (EWS/BC/EBC/SC/ST), PWD Certificate and BMC/NMC registration certificate.

Selection Procedure:

- 1. Junior Resident (Non Academic) selection / appointment will be according to NEET- PG Score. Panel is valid for 12 months only.
- 2. The selected candidates shall be allotted department on the basis of availability of vacancy in that department, merit-cum-choice and requirement in the Institute.

LEAVE:

 Junior Residents (Non Academic) are entitled for 2 ½ day leave per completed month of service. Leave will be credited to their account on every 15th day of a month.

2. Leave without permission or more than the permitted period will be treated as absentee and will be dealt as considered as being within notice period.

3. Ordinarily leave will be granted for maximum of 05 days in continuity and will be permissible subject to discretion of the HOD. Medical Emergency may be considered under exceptional cases, which will be at the

4. All leave must be sanctioned prior to proceeding on leave except in medical emergency in which case the Medical Superintendent.

5. Absorbed Leave with the sanctioned prior to proceeding on leave except in medical emergency in which case the Medical Superintendent.

5. Absence/ Leave without information for more than 7 days will lead to termination of appointment Re- joining of duties will not be accepted during the last months / tenure of completion/extended period.

6. In case candidate wants to quit the Junior Residency mid-way he/she will be required to give either one month's prior notice or deposit one month's salary.

7. No leave (except for medical emergencies) will be permitted in the notice period.

DUTIES & RESPOSIBILITIES

Duties and responsibilities of Junior Residents will be fixed by the Institute from time-to-time as per the requirement in the interest of patient care in the hospital. This includes emergency duties.




ASSESSMENT

At the end of first 06 (Six) months of the Junior Residency, each Junior Resident will be assessed and in case his/her performance is not found satisfactory, his/her appointment shall be terminated.

GENERAL INSTRUCTIONS

- 1. Application form can be downloaded from our website www.igims. org. The cost of application form:- Rs.1000/- (Rupees One Thousand) for UR//EWS/BC/WBC and Rs. 250/- (Rupees Two Hundred & Fifty) for SC/ST/EBC candidate (Non-Refundable) payable to The Director, IGIMS, at Patna, in the form of Demand Draft.
- 2. The applications completed in all respect along with self attested photocopies of certificates/ testimonials and recent passport size photograph <u>as well as requisite fee</u> must reach by registered/speed post/Courier to the <u>Director, IGIMŞ, Sheikhpura.</u>

 Patna-14 (Bihar) on or before "20-01-2025 till 04-00 PM.
- 3. Candidates employed in Government/Semi Government organization or by any other employer, must submit their application along-with "No Objection Certificate" issued by the employer. If not employed they must submit in writing that they are neither employed in any organization nor doing any course anywhere.
- 4. Benefit of reservation will be given to Bihar State domicile only and the applicant out-side the State of Bihar will not be entitled for the benefit of reservation. It is requested to bring domicile certificate where applicable. Handicapped person/candidate will be given the benefit of reservation as per Bihar Govt. rule. Person working in Govt. Institution shall be given relaxation as per rule.



- 6. In addition to Pay + NPA, other allowances will be admissible as per rule.
- 7. The posts are non-practicing & Private Practice of any kind, direct or in-direct including laboratory, is strictly prohibited, if found guilty, appointment of candidate shall be terminated.
- 8. Stay in campus is compulsory, if accommodation is provided. If not provided, HRA's admissible as per rule.
- 9. The Selection Committee's panel will be valid for 12 (twelve) months only
- 10. The Director of the Institute reserves the right to reject/accept any or all the applications without assigning any reason and cancel the advertisement.
