





Notice for 3rd (Final) Counselling

In continuation to Notice for Counselling vide Memo No. 2633/Acad. dated 23/10/2024 and 2349/Acad. dated 21/09/2024, schedule of 3rd (Final) Round of Counselling for admission to courses- Bachelor of Physiotherapy, B.Sc.(Nursing) & Allied Health Sciences and GNM-2024 is given below:

While allotting seat for admission to B.Sc. Nursing, the minimum qualifying criteria would be 50th Percentile for General and 40th Percentile for SC/ST/OBC. On the other hand, in the process of admission to other courses and GNM the minimum criteria shall be 32 percentile for SC/ST, 34 percentile for EBC, 36.5 percentile for BC/EWS and 40 percentile for General candidates.

Candidates are required to bring their following original & self attested photocopy of certificates for counselling:

- NEET (UG) – 2024 Re-revised Score Card
- Identity Proof
- Matriculation Certificate (Both Marks sheet and Passing Certificate).
- Intermediate Sciences or its equivalent (Both Marks sheet and Passing Certificate).
- Migration Certificate or its equivalent certificate.
- College Leaving Certificate
- Caste & Domicile Certificate to claim for Reservation (for married female candidates, Caste Certificate of father side and Domicile Certificate of husband side will be required)
- In case of widow/divorcee a certificates issued by the competent authority must be submitted (for B.Sc. Nursing/ GNM Candidates).
- Affidavit that the student is not pursuing any other course in any other university at the time of Admission.
- Affidavit for justifying gap in the academic qualification.
- 04 Passport size photographs (colour)
- Demand Draft of Rupees 10,000/- (Ten thousand) only in favour of Director, IGIMS, Patna (non-refundable) for allotment of seat. Without Demand Draft, seat will not be allotted.**
- Filled up counselling form
