The detailed technical specifications along with terms & conditions for the same were uploaded at Institute website www.igims.org. The bids were obtained under two packets (i.e. technical & financial) systems. The last date of submission was 01.10.2020. The received bids (technical only) were opened in its meeting held on 05.10.2020.

As per terms and conditions of the bidding document, the **Pre – Qualification Criteria** were as follows:

- o Bidders should be the Manufacturer / authorized Dealer / Distributor / Trader / Supplier. Letter of Authorization from Manufacturer for the same and specific to the tender should be enclosed.
- o Bidder must provide evidence of having supplied at government hospital / reputed private hospital organizations in India similar nature of items.
- o Non-compliance of tender terms, non-submission of required documents, lack of clarity of the specifications, contradiction between bidder specification and supporting documents etc. may lead to rejection of the bid.
- o Furnishing of wrong/ambiguous information in the compliance statement may lead to rejection of bid and further black listing of the bidder, if prima-facie it appears that the information in the compliance statement was given with a malafide/fraudulent intent.

The “Local Purchase Committee” in its meeting held on 21.01.2021 has examined each bids and was of the opinion to call the bidders for free demonstration of the quoted furniture’s at a pre-determined place (proposed - In front of Medical College Building) acceptable to the tender inviting authority for technical acceptability of the furniture before opening of the price bid. It was also decided to fix a sticker duly signed on each verified samples of the bidders after verification. It will be the responsibility of the bidders to keep the verified samples in safe custody and submit to Institute if they declared successful after price bid opening. The videography of the sample verification process should be done for future references. The Committee was also of the opinion to call one member from Civil Engineering Cell (not below the rank of Executive Engineer) as an Expert to assist the committee during sample verification.

It was also agreed that, in case, the quoted bidders do not participate in sample verification / demonstration; their bid shall not be evaluated further and summarily rejected.

Accordingly, “Local Purchase Committee” was of the opinion to call the bidders for sample verification as per following scheduled.
