The bidders or their authorized representatives may also be present during the opening of the Technical Bid, price bid if they desire so, at their own expenses.

- (i) <u>Average Annual Turnover:</u> Notarized photocopy average turnover of the bidder in the last three financial year
- (ii) **EXECUTION OF SIMILAR CONTRACTS**: Notarized photocopy of the similar nature of work carried out by the agency in last 3 Years etc. must be submitted by the Bidder.

 - Balance 5% (Five Percent) Security Money shall be deducted from each running account bill of work done under this work order.
 - Security deposit shall be refunded after expiry of warranty period (12 months from the date of completion of work order) provided, there are no defects in work.
