The sealed quotations should reach the Institute, latest by 26.09.2023 and it will be opened 27.09.2023 in the presence of the bidder(s) or their authorized representative(s), who will be present at the scheduled date and time.

Term & Conditions

- 1. Preparation and Submission of Tender: The tender should be submitted in two parts i.e. Technical Bid and Financial Bid. The Technical Bid and the Financial Bid should be sealed By the bidder in two separate covers "Technical Bid" and "Financial Bid". Both Sealed Envelopes should be kept in a main/ bigger envelope super-scribed as "Tender for Supply of Hospital Furniture (i.e. Fowler Bed with Four Section Mattress, Attendants Bed with Mattress, Over Bed Table and Bed Side Locker)".
- 2. Earnest Money Deposit: The bidder shall be required to submit the Earnest Money Deposit (EMD) of ₹10,00,000/- (Rupees: Ten Lac Only) by way of Demand Drafts only, The demand drafts shall be drawn in favour of "Director", Indira Gandhi Institute of Medical Science, Patna. (payable at Patna) The demand drafts for earnest money deposit must be enclosed in the envelope containing the technical bid. The EMD of the successful bidder shall be returned after the successful submission of Bank Guarantee/ Security Deposit and for unsuccessful bidder(s) it would be returned after award of the contract. Bid(s) received without demand drafts of EMD will be rejected.
 - a. Request for transfer of any previous deposit of earnest money or security deposit Or payment of any pending bill held by the respect of any previous work will not be entertained.
 - b. Tenderer shall not be permitted to withdraw his offer or modify the terms and Conditions thereof, In case the tenderer fail to observe and comply with stipulation made herein or backs out after quoting the rates, the aforesaid amount of earnest money will be forfeited.
 - c. The tender without Earnest Money and tender fee will be summarily rejected. The Firm who are registered with National Small Industries Corporation (NSIC) / OR Small Scale Industries (SSI) are exempted to submit the EMD (Copy of registration must be provide along with technical bid).
 - d. The EMD, in case of unsuccessful Bidders shall be retained by IGIMS, Patna till the finalization of the tender. No interest will be payable by IGIMS, Patna on the EMD.
 - e. EMD may also be submit in form of Bank Guarantee.
- 3. Tender Fee: Tender fee will be Non-refundable amount of Rs. 2,500/- (Rupees Two thousand five hundred only) by way of demand drafts only. The demand drafts shall be drawn in favour of "Director, Indira Gandhi Institute of Medical Science -Patna".
- 4. Date of Pre- Bid Meeting on 31 / 08 / 2023 in the Conference Hall, Ground Floor, Administrative Block, IGIMS- Patna.
- **5. Rate**: Rate should be quoted in Indian Rupees (INR) on DOOR Delivery Basis at IGIMS, Patna inclusive of all the Charges, with break-ups as:
- Basic Cost.
- GST.
- Total Cost
- The quoted rate should be valid for a period of three years from date of finalization of the purchase by the competent authority. Quantity of the proposed items are tentative in nature. Purchase will be made on as and when required basis.

6. Opening of Tender:

The tenderer is at liberty to present either him or authorize not more than one representative to be present at the opening of the tender. The representative present at the opening of the tender on behalf of the tenderer should bring with him a letter of authority from the tenderer and proof of identification

7. Validity of the bids:

The bids shall be valid for a period of 180 days from the date of opening of the tender. This has to be so specified by the tenderer in the commercial bid.

8. Right of acceptance:

IGIMS, Patna reserve the right to accept or reject any or all tenders /quotations without assigning any reason there of and also does not bind itself to accept the lowest quotation or any tender.

Any failure on the part of the contractor to observe the prescribed procedure and any attempt to canvass for the work will prejudice the contractor's quotation or any tender.

9. Communication of Acceptance / Right of Acceptance :

IGIMS, Patna, reserves all right to reject any tender including of those tenderers who fails to comply with the instructions without assigning any reason whatsoever and does not bind itself to accept the lowest or any specific tender. The decision of this Institute in this regard will be final and binding. Any failure on the part of the contractor to observer the prescribed procedure and any attempt to canvass the work prejudice the contractor's quotation.

- 10. Signing the Contract: The successful bidder shall be required to execute the Contract Agreement accepting all terms and conditions stipulated herein on a non-judicial stamp paper of Rs. 1000/- (Rs. One Thousand only) along with performance security within fifteen days of the issue of the Letter of notification of award. In the event of failure on the part of the successful bidder to sign the Contract within the period stipulated above, the EMD shall be forfeited and the acceptance of BID shall be considered as cancelled.
- 11. Performance Security: As a guarantee towards due performance and compliance of the Contract work, the successful bidder (contractor) will deposit an amount equal ₹10,00,000/- (Rupees: Ten Lac Only) and should be kept valid for a period of 60 day beyond completion of all the contractual obligation, including CMC period towards security deposit by way of demand draft/ bank Guarantee in favour of "Director Indira Gandhi Institute of Medical Science, Patna" drawn on any Nationalized Bank/Scheduled Bank and payable at Patna within fifteen days of the issue of the Letter of notification of award along with non-judicial stamp paper of ₹1000/- (Contract agreement).

12. Delivery & Installation:

All the goods ordered shall be delivered and Installed at IGIMS, Patna within 30 days from the date of issue of purchase order. Satisfactory installation / commissioning and handover of the furniture will be completed within two weeks from the date of receipt of the furniture at IGIMS, Patna premises.

All the aspects of safe delivery, installation and commissioning shall be the exclusive responsibility of the supplier. If the supplier fails to deliver, install and commission the goods on or before the stipulated date, then a penalty at the rate of 0.5% per week of the total order value shall be levied subject to maximum of 10% of the total order value.

If at any time during the currency of the contract, the supplier encounters conditions hindering timely delivery of the goods and performance of services, the supplier shall promptly inform IGIMS, Patna in writing about the same and its likely duration and make a request to IGIMS, Patna for extension of the delivery schedule accordingly. On receiving the supplier's communication, IGIMS, Patna shall examine the situation as soon as possible and, at its discretion, may agree to extend the delivery schedule, with or without liquidated damages for completion of supplier's contractual obligations by issuing an amendment to the contract.

13. The delivery of the items will have to be made at Central Store Section, IGIMS- Patna. No transportation/

cartridge charges will be provided for the same.

14. The rate quoted should be firm and final and written in ink or typed against each item and should in no case be overwritten.

15. Inspecting ,Testing and Quality control

- a. The IGIMS, Patna or its nominal representative reserve the right to inspect and test the ordered goods and the related services to confirm their conformity to the contract specification and other quality control details incorporated.
- b. The IGIMS, Patna reserves the right for stage inspection during manufacturing process, pre-dispatch inspection or post-delivery inspection. The IGIMS, Patna as deemed fit shall resort to all these inspection or may waive off any of the inspection.
- c. Stage Inspection: The Supplier shall offer/ send semi-finished product without paint for stage inspection supported with invoice & test report of major raw material as per relevant specification standards.
- d. Before resorting to Bulk Manufacture, the supplier shall offer/send the Prototype/actual finished sample for approval by IGIMS, Patna. The approval of Samples shall be in respect of workmanship and finishing and shall be without prejudice to the rights of IGIMS, Patna to get random testing of items during pre-dispatch inspection or form the actual lot offered. In the event of the failure of the supplier to deliver the sample by the date specified in the contact or any other date agreed by IGIMS, Patna or in the event of rejection of the sample second time, IGIMS, Patna shall be entitled to cancel the contract and purchase the stores at the risk and cost of the supplier.
- e. The IGIMS, Patna shall have full and free access at any time during the execution of the contract to the supplier's work for satisfying itself that the goods are being manufactured in accordance with the specification mentioned in the Contract, and may require the Supplier to make arrangements of inspection of the goods or any part thereof or any material at his premises or at any other place specified by IGIMS, Patna and if the Supplier has been permitted to employ the services of a sub-inspection of the goods after they have been inspected by IGIMS, Patna for the purpose aforesaid. The decision of IGIMS, Patna in this regard shall be final and binding on the Supplier. All terms and condition of the contract as they apply to the inspection shall also apply to the re-inspection.
- f. The Supplier shall provide, without any extra charge, all material, tools, labour and assistance of every kind which IGIMS, Patna may demand of him for any test, and examination, which he shall require to be made on the Supplier's premises and the Supplier shall bear and pay all costs attendant thereon. If the Supplier fails to comply with condition aforesaid, IGIMS, Patna shall, in his sole judgment, be entitled to remove for test and examination all or any of the goods manufactured by the Supplier to any premises other than his (Supplier's) and in all such cases the Supplier's shall bear the cost of transport/and carrying out such tests elsewhere. A certificate in writing of IGIMS, Patna that the Supplier has failed to provide the facilities and the means for test and examination, shall be final.
- g. The Supplier shall also provide and deliver for test, free of charge, at such place other than his premises as IGIMS, Patna may specify such material or goods as he may require for tests for which Supplier does not have the facilities or special/independent tests
- h. The IGIMS, Patna shall have the right to put all the goods or materials forming part of the same or any part thereof to such tests as he may think fit and proper. The Supplier shall not be entitled to object on any ground whatsoever to the method of testing adopted by IGIMS, Patna
- i. Goods accepted by the purchase/IGIMS, Patna and/or its IGIMS, Patna at initial inspection and in final

inspection in terms of the contract shall in no way dilute IGIMS, Patna right to reject the same later.

j. The IGIMS, Patna reserves the right to draw samples through random sampling method after receiving the finished goods at destination. All the supplies shall be accompanied with the Manufacturer's certificate that the material conforms to the specifications.

Further to above if on the goods being rejected by IGIMS, Patna at the destination, the Supplier fails to make satisfactory supply within the stipulated period of delivery IGIMS, Patna shall be at liberty to:-

- a. Require the Suppler to replace the rejected goods forthwith but in any event not later than a period of 30 days from the date of rejection and the Supplier shall bear all cost of such replacement, including freight, if any, on such replacing and replaced goods but without being entitled to any extra payment on that or any other account.
- b. Purchase or authorize the purchase of quantity of the goods rejected or goods of a similar description when goods exactly complying with particulars are not in the opinion of the Purchase, which shall be final, readily available without notice to the supplier at his risk and cost and without affecting the Supplier's liability as regards the supply of any further installment due under the contract, or
- c. Cancel the contract and purchase or authorized the purchase of the goods or goods of a similar description (when goods complying with particulars are not in the opening of the Purchase, which shall be final, readily available) at the risk and cost of the Supplier.
- d. The IGIMS, Patna shall have the power:-
- Before any goods or part thereof are submitted for inspection to certify that they cannot be in accordance with the contract owing to the adoption of any unsatisfactory method of manufacture.
- To reject any goods submitted as not being accordance with particulars.
- To reject the whole of the installment tendered for inspection, if after inspection of such portion thereof as he may in his discretion think fit, he is satisfied that the same is unsatisfactory.
- To demand all cost incurred in the inspection and/or test, cost of test shall be assessed at the rate charged by
 the Laboratory to private persons for similar work However if goods are accepted all cost incurred shall be
 borne by IGIMS, Patna. IGIMS, Patna's decision as regards the rejection shall be final and binding on the
 Supplier.

16. Guarantee / Warranty:

- The on-site replacement warrant shall remain for a period of **36 Months** from the date of recording of acceptance of goods at site.
- During warranty period, the supplier is required to visit IGIMS, Patna site at least once in 4 months commencing from the date of delivery of the goods for **preventive maintenance** of the goods.
- If the supplier having been notified, fails to respond to take action to replace the defect(s) within 07 days IGIMS, Patna may proceed to take remedial action(s) as deemed fit.

17. Liquidated Damages

If the supplier fails to deliver any or all of the goods or fails to perform the service within the time frame(s) incorporated in the tender, IGIMS, Patna shall, without prejudice to other right and remedies available to IGIMS, Patna under the tender, deduct from the quoted price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of goods and/or services until actual delivery or performance subject to a maximum of 15 % of the quoted price. Once maximum is reached IGIMS, Patna may consider termination of the tender.

18. FORCE MAJEURE:

If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of public enemy, civil commotion, sabotage, fire, floods, explosion, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by party to other within 21 days from the date of occurrence thereof, neither party hall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non- performance or delay in performance, and deliveries have been so resumed or not shall be final and conclusive.

Further, that if the performance in whole or in part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, IGIMS, Patna party may, at least option to terminate the contract.

19. Insolvency etc.:

In the event of the firm being adjudged insolvent or having a receiver appointed for it by a court or any other order under the Insolvency Act made against them or in the case of a company the passing any resolution or making of any order for winding up, whether voluntary or otherwise, or in the event of the firm failing to comply with any of the conditions herein specified IGIMS, Patna shall have the power to terminate the contract without any prior notice.

20. Breach of Terms and Conditions:

In case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to cancel the work order/ job without assigning any reason thereof and nothing will be payable by IGIMS, Patna. In that event the security deposit shall also stand forfeited.

21. Subletting of Work:

The firm shall not assign or sublet the work/job or any part of it to any other person or party without having first obtained permission in writing of IGIMS, Patna, which will be at liberty to refuse if thinks fit. The tender is not transferable. Only one tender shall be submitted by one tenderer.

22. Right to call upon information regarding status of work:

The IGIMS, Patna will have the right to call upon information regarding status of work/job at any point of time.

23. Terms of payment:

100 %Payment shall be released after the successful installation of the ordered goods against the submission of the Inspection report by the committee.

24. Arbitration:

If any difference arises concerning this agreement, its interpretation on payment to the made there under, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to the other party for submission of the dispute for decision by an Arbitral Tribunal containing Sole Arbitrator to be appointed by Director, IGIMS, Patna. Such requests shall be accompanied with a panel of names of

three persons to act as the sole arbitrator. In case of such arbitrator refusing, unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed

in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation Act, 1990 and the rule framed there under and in force shall be applicable to such proceedings.

25. Legal Jurisdiction:

The agreement shall be deemed to have been concluded in Jodhpur, Rajasthan and all obligations hereunder shall be deemed to be located at Jodhpur, Rajasthan and Court within Patna, Bihar will have Jurisdiction to the exclusion of other courts.

26. Sample:

Sample of the item is to be submitted by the bidder for evaluation. Date and time for sample verification will be informed to all the bidders through e-mail and mobile. The same will also be uploaded at institute website.

27. Incidental Services:

The supplier shall be required to perform the following services:-

- a.Installation & Commissioning, Supervision and Demonstration of the goods.
- b.Providing required jigs and tools for assembly, minor civil works required for the completion of the installation.
- c. Supplying required number of operation & maintenance manual for the goods.

28. After Sales Service:

After sales service centre should be available on 24 (hrs.) X 7 (days) X 365 (days) basis. Complaints should be attended properly, maximum within 24 hours to ensure an uptime of minimum 95%, wherever applicable, failing which the necessary penalty measures shall be enforced (95% of 365 days irrespective of Sunday and Gazetted Holiday).

29. Inspection:

- a. IGIMS, Patna shall have the right to inspect and/or to test the goods to confirm their conformity to the NIT Specifications at no extra cost to IGIMS, Patna.
- b. IGIMS, Patna reserve the right to inspect, test and, where necessary, reject the Goods after the goods have arrived at the final destination and it shall in no way be limited or waived by reason of the Goods having previously been inspected, tested and passed by IGIMS, Patna prior to the goods shipment.
- c. The Director, IGIMS, Patna shall be the final authority to reject full or any part of the supply which is not conforming to the specification and other terms and conditions.
- d. No payment shall be made for rejected goods. Rejected items must be removed by the bidders within two weeks of the date of rejection at their own cost and replaced immediately. In case these are not removed, these will be auctioned at the risk and responsibility of the suppliers without any further notice.

30. Documents:

- a. All pages of the Tender should be numbered and indexed.
- b. The bidder shall provide in its tender the required as well as the relevant documents like technical data, literature, drawings etc. to establish that the goods and services offered in the tender fully confirm to the goods and services specified by IGIMS, Patna in the tender documents. For this purpose the bidder shall also provide a clause-by-clause commentary on the technical specifications and other technical details incorporated by IGIMS, Patna in the tender documents to establish technical responsiveness of the goods and services offered in its tender duly indicating relevant page numbers in the product literature.

31. Quantity:

Quantity may increase or decrease as per requirement of the Institute. The quantity of the proposed items are tentative in nature. Tendered quantity may not be purchased in one lot. Purchase will be made on as and when required basis.
