Sealed quotations are hereby invited from manufacturer or parties having requisite expertise for the repair and maintenance of "Surgical Operating Microscopes (Make: Leica Ag – Switzerland, Model: M - 690 & M - 840)" installed at Regional Institute of Ophthalmology of this institute. The scope of work should include repair, replacement of defective spare parts and calibration of both the Surgical Operating Microscopes for its satisfactory functioning.

Interested parties can inspect the above-mentioned "Surgical Operating Microscopes (Make: Leica Ag – Switzerland, Model: M – 690 & M – 840)" at Regional Institute of Ophthalmology, I.G.I.M.S. - Patna and make further inquiries with Head – R.I.O. / Senior Bio-Medical Engineer of the institute on any working days between 10:00 AM to 4:00 PM.

It will be mandatory for the bidder(s) to provide warranty period of one year after repair / replacement of the spare parts / maintenance of the complete system and also submit their rate for Comprehensive Annual Maintenance Contract / Annual Maintenance Contract for further period of two years.

Warranty Period / Annual Maintenance Contract / Comprehensive Annual Maintenance Contract should include four nos. of maintenance visits per year at regular interval for usual maintenance and supervision with breakdown visits as and when required. During warranty period / Comprehensive Annual Maintenance Contract, all the spares and consumables are to be provided by the bidder. However, during Annual Maintenance Contract spares and consumables will be procured by the institute as and when required. Further, it will be the responsibility of the bidder to maintain the system individually with a uptime guarantee of 95% (of 365 days) failing which proportionate deduction in contract amount will be done. Payment towards Annual Maintenance Contract / Comprehensive Annual Maintenance Contract shall be made on half yearly basis on submission of satisfactory report by the officials authorized by the competent authority.

A sum of **Rs. 5, 000/- (Rs. Five Thousand Only)** is to be submitted in form of Bank Draft in favour of **"Director, I.G.I.M.S. – Patna (payable at Patna)** as a security deposit along with self attested following documents are to be attached with quotation.
