Bihar, Building Construction Department, CPWD, Bihar Rajya Pul Nirman Nigam, PHED Bihar, Bihar Rajya Vidyut Board, Railway for civil works in appropriate class having PAN NO., latest character certificate from District Magistrate / Superintendent of Police, VAT NO., Labour Registration Certificate and experience certificate of work done not less than 80% value of single work or two work of 60% value or four work of 40% value of estimated amount in the last three years ending March 2015.
- (3) For Electrical work bidder has to submit the copy of their Electrical Contractor License issued to agency or his authorized representative from Bihar Energy Department.
