

Outcome of pre-bid meeting held on 30.08.2017 at 3:30 P.M. in Conference Hall of the Institute against Tender Notice No.: 10 / 2017 – 18 / MPGS – Ward Block / IGIMS / STORE towards Supply, Installation and Commissioning of Centralized Medical Gas Pipeline System at each floor of the Institute.

Doubts raised by prospective bidders were acknowledged and made clear during discussion. After careful consideration of the points raised by the various prospective bidders and to ensure maximum participation of the bidders, following amendment in technical specifications of the proposed items are being made:

a. Vacuum System:

Specifications mentioned in the Bidding Document	Should be read as follows:
a. Supply system for vacuum shall comprise at least three sources of supply, one reservoir, two parallel bacterial filter and one drainage trap, to suitably ensure flow rate of vacuum as per the international norms at each outlet.	a. b. Payment Terms:
