

Candidates have to bring their following original & self attested photocopy of certificates for the counselling:

- (i) Identity Proof (like Aadhar card/Driving License).
- (ii) Matriculation Certificate (Both Marks sheet and Passing Certificate).
- (iii) Intermediate Sciences or its equivalent (Both Marks sheet and Passing Certificate).
- (iv) Migration Certificate or its equivalent certificate.
- (v) College Leaving Certificate.
- (vi) GNM Mark sheet & Passing certificate.
- (vii) RNRM Registration with any State Council.
- (viii) NOC from current employer.
- (ix) Caste (EWS/BC/EBC/SC/ST) certificate & latest Domicile (Residence) Certificate to claim for Reservation (for married female candidates, Caste Certificate of father side and Domicile Certificate of husband side will be required)
- (x) In case of widow/divorcee a certificates issued by the competent authority must be submitted (for B.Sc. Nursing/ GNM Candidates).
- (xi) Affidavit that the student is not pursuing any other course in any other university at the time of Admission.
- (xii) Affidavit for justifying gap in the academic qualification.
- (xiii) 04 Passport size photographs (colour)



(xiv) Demand Draft of Rupees 10,000/- (Ten thousand) only in favour of Director, IGIMS, Patna (non-refundable) for allotment of seat.

Without Demand Draft, seat will not be allotted.

You will be required to submit the above mentioned documents at the time of counseling.
