Admission Notice for Post Doctoral Certificate Course (PDCC). Advt. no. 04/ Acad/ 2020 Corrigendum

- 4. Guidelines for admission of "Sponsored Candidates"
- A. Admission to various courses is open for candidates sponsored by Central/State government organizations, universities or defence services, subject to following conditions:
- 1) Sponsored candidate will not be given relaxation in method of selection, duration of course, practical training, pattern of examination and payment of prescribed fee, etc. except relaxation in age as per rules.
- 2) IGIMS, Patna will not pay sponsored candidates any salary, stipend or any other emoluments during entire training period.
- 3) Candidate should provide a certificate from sponsoring authority that:
- a. Candidate is a permanent employee of sponsoring organization.
- b. She/he will be granted leave for 1 year in case of PDCC programs.
- c. Candidate after completing course will be suitably employed by sponsoring organization to work in specialty in which training is provided.
- d. Sponsoring authority shall be responsible for payment of salary or any other emoluments to candidate during period of training.
- e. A state government can sponsor candidates only for those courses which are not available in that state.
- A certificate regarding non-availability of course (for which candidate is being sponsored) in the concerned state, duly signed by the competent authority/ head of the organization should be furnished.
- 4) Sponsorship certificate in original should be attached with application form, failing which sponsorship will not be entertained.
- 5) All eligible "sponsored" candidates will be called for an entrance test.

B. Requirements for IGIMS, Patna faculty for PDCC programme under sponsored category:

- 1) Members of faculty can apply for registration to PDCC course as in service candidate.
- 2) At any time only one out of 5 Faculty members in the department can be registered for PDCC courses and not more than 2 candidates in the department at any given time will be registered as PDCC candidates where there are more than 5 faculty members.

- 3) Individual opting to pursue course should be below 50 years of age.
- 4) Faculty should be a regular employee of Institute & should have rendered a minimum of 5 years continuous service as faculty at Institute.
- 5) Candidate admitted under this category will be considered as in service candidate provided Head of Department certifies that (a) such training will help in patient care/teaching/research of Department (b) work of department will not suffer and no additional staff will be asked for.
- 6) Faculty member who has registered himself/herself for PDCC course will not be eligible to be Guide/Co-Guide of any other candidate in the concerned department during the period he/she is undergoing course.
- 7) (a)Faculty members may apply through proper channel as sponsored candidates and appear for entrance examination.
- (b) They can apply through proper channel for open entrance examination if sponsored seats are not available.
- 8) Candidates selected for pursuing said course have to pay PDCC fee etc.
- 9) Faculty member has to execute a bond that he/she will serve institute for a period not less than five years after completing said course failing which they are liable to return total salary, allowances and any amount paid to them by institute during their course along with a penalty amount of Rs.20 Lakhs. In case of violation of compliance of provisions of executed bond appropriate legal action shall be initiated against defaulters.
- 10) During period of course, in-service faculty member will be treated as on study leave.
- 11) Period of study leave for said course within same Department or within IGIMS will be counted for purpose of A.P.S.
- 12) Candidate/faculty will not be entitled for winter/summer vacation during entire course and he/she will be eligible for leaves as per Residency Scheme.
- 13) Duties/Responsibilities of trainee will be as per Residency Scheme.
- 14) In-service candidates will have option to pursue this course in any stream, subject to availability of seats and forwarding of their applications through proper channel.
- 15) Candidate/faculty will be allowed to avail of study leave for pursuing PDCC courses only once during entire service.
