

- (ix) Current Caste & Domicile Certificate to claim for Reservation (for married female candidates, Caste Certificate of father side and Domicile Certificate of husband side will be required)
- (x) In case of widow/divorcee a certificates issued by the competent authority must be submitted (for B.Sc. Nursing/ GNM Candidates).
- (xi) Affidavit that the student is not pursuing any other course in any other university at the time of Admission.
- (xii) Affidavit for justifying gap in the academic qualification.
- (xiii) 04 Passport size photographs (colour)
- (xiv) Demand Draft of Rupees 10,000/- (Ten thousand) only in favour of Director, IGIMS, Patna (non-refundable) for allotment of seat. Without Demand Draft, seat will not be allotted.

You will be required to submit the above mentioned documents at the time of counseling.
