REQUIRMENTS

- (i) Production of certificate of fitness from the Medical Board of this Institute.
- (ii) Production of original certificates in support of age, qualification, experience, registration (Caste & domicile-If applicable) etc.
- (iii) Relieving certificate from previous employer, if any. If you are not submitting relieving letter from your previous employer, then you will have to submit an affidavit to the effect that you are neither employed nor doing any course else-where.
- (iv)A- Candidates belonging to SC/ST category must submit their Caste Certificate duly issued by Circle Officer of their respective Circle/District of Bihar.
 Candidate belonging to EBC/BC must submit their caste certificate along-with Certificate of exemption from
- B- creamy-layer duly signed by Circle Officer of their respective Circle/District of Bihar.
- (v) Your joining will not be accepted without submission of Medical Fitness & furnishing of certificates as referred above.

TERMS & CONDITIONS

- 1. During your tenure Fellowship in Emergency Critical Care Programme at this Institute you will be guided by the Institute's Rules for every matter including leave.
- 2. The post is **non-practicing** and private practice of every kind (<u>Direct or Indirect</u>) including laboratory and consultant practice is strictly prohibited.
- 3. Stay in the Institute's campus is compulsory, if accommodation is provided. If not provided, HRA's admissible as per rule.
- 4. You will be paid Rs. 67700/- during 1st year, and Rs. 69700/- in 2nd year + NPA + usual allowances as admissible for Fellowship in Emergency Critical Care in this Institute.
- 5. You will have to deposit training charges under following heads each year in the form of Demand Draft in favour of Director, IGIMS, Patna payable at Patna. (Non Refundable).
 - (a.) Registration fee (One Time) Rs. 10,000/- (Ten Thousand only)
 - (b.) Tuition Fee (inclusive of Laboratory & Library fee) Rs. 100000/- (one Lac only) per Annum
 - (c.) Electricity As applicable on consumption basis
 - (d.) Admission Charge (One Time) Rs. 10,000/- (Ten Thousand Only)
 - (e.) Examination fee will be charged extra Dean Exam- as per IGIMS rules.
 - (f.) (Examination fee to be fixed by the Dean Exam Cell)- as per IGIMS rules.

Emergency Critical Care Trainees can avail leave: 1st Year 24 days 2nd Year:- 30 days leave in a calendar year.

6. After joining, you will not be given "No Objection Certificate" & Experience Certificate by the Institute for making any application in other Institute for the first 12 months. Only after completion of your 1st year the course, The Institute you will consider for providing No Objection Certificate/Experience Certificate for making any application in other Institute/Hospital, for which you will have to submit your such application (Duly forwarded & Recommended by your Head of the Department) at least 15 days well in advance to enable the office to process it properly.

7. Candidate with draws from course fee is non refundable and has to pay a penalty of Rs. 5,00,000/- (Five Lakhs only), applicable to non sponsored candidates also.

All claims/certificate must be collected by you within 03 (Three) months, from the date of issue of final relieving order, on submission of No Dues Certificate etc., on completion of Fellowship in Emergency Critical Care

You will be promoted from 1st year to 2nd year of Fellowship programme, subject to the following conditions:-

A- Satisfactory performance report from concerned Head of the Department.

- B- Satisfactory performance report of Medical Superintendent on your clinical work, other assigned duties and your conduct etc.
- 10 You will participate in teaching and research programme of the Institute as decided by the Institute from time to time.

11 You will be required to publish paper/procedure research work as specified by the Institute, from time to time.

12 You are liable to serve in any Rural Health Centre of the Institute, if so required.

13 If any information submitted by you is/are found wrong in future, your selection into Fellowship Programme will be terminated and suitable action will also be taken against you.

If, the above terms and conditions are acceptable to you please communicate your acceptance to the undersigned within 10 Days, from the date of issue of this letter and report on or before: 10 March2022 failing which the offer shall stand withdrawn and offer will be given to the waiting list candidate.

No travelling and other allowances are payable for joining the Fellowship in Emergency Critical Care Programme/Tutor's post.
