02	Medical Physics	 Essential Qualifications: - A postgraduate qualification i.e. M.Sc in Medical Physics or M.Sc in Physics with Postgraduate diploma in Radiological Physics from a recognized institution or a recognized qualification equivalent thereto. A Doctorate Degree from a recognized university. Experience:- Three years teaching and / or research experience in recognized institution in the discipline / subject of specialty concerned after obtaining the doctorate degree.

NOTE: DNB Equivalence: - In case of those who are holding DNB in broad specialties or super specialty as qualifying education, they have to produce documentary evidence issued by Competent /Appropriate authority about DNB equivalence with MD/MS/DM/M.Ch. as per MCI, New Delhi notification dated 31-10-2018.

Those who have undergone DNB training from institution given under Para 2 at (a) & (b) of aforementioned MCI notification – will not need to have extra experience after qualifying degree.

Those who have undergone DNB training at Institution given at (c) & (d) of aforementioned MCI notification will need to have 1 year & 2 years extra experience i.e. total 4 & 5 years experience respectively from MCI recognized / permitted institution for equivalence.

- <u>The cost of Application</u>: The cost of application form (*Non-refundable*) is Rs. 1000/- One Thousand (<u>Rs. 250/- Two</u> <u>Hundred &Fifty: for EBC/SC/ST candidates</u>). The application-form completed in all respect along-with requisite application fee (*Non-refundable*), must be accompanied with Demand Draft, drawn in favor of <u>Director, IGIMS, Patna-</u> <u>14</u>, payable at Patna. <u>Application/s not accompanying the cost of application shall be rejected</u>.
- After selection and issue of appointment letter, discharge/relieving certificate after resignation from the previous employer, is essential before joining.
- 4. In addition to Pay, NPA (For Medical candidate only) and other allowances will be admissible as per rule for regular appointment.
- The posts are <u>non-practicing</u> and private practice of any kind, direct or in-direct, including laboratory practices is strictly prohibited. If found indulging in such practices, appointment of the candidate shall be terminated.
- 6. Stay in the campus is compulsory, if accommodation is not provided, HRA is admissible as per rule.
- 7. Reservation point and relaxation in upper age limit will be applicable as per rule of Govt. of Bihar. Reservation benefit shall be applicable to Bihar State Domicile candidate only and the applicant from out-side the State of Bihar will not be entitled for the reservation. <u>Physically-Handicapped candidate will be given the benefit of reservation and relaxation as per rule of Govt. of Bihar. Person working in Govt. Institution shall be given relaxation as per rule.</u>
 - 1. The reservation for BC/EBC/SC/ST/EWS & Female candidates is as per Bihar Govt. rules and 4 % for PWD including OPH candidates (on horizontal basis.)
 - For BC/EBC candidate: Candidates must attach certificate valid for the posts under prescribed by the Government of Bihar which mentions that the candidate does not belong to Creamy Layer (form –X). Date of issue of Certificate should not earlier than 01 years from the date of interview.
 - 3. EWS certificate should have been issued after 01-04-2024 till date of interview.
 - 4. FOR SC, ST, EWS & PWD certificate should be issued by authorities prescribed by Govt. of Bihar.
- Candidates who are employed must apply through proper channel. In case of advance application "<u>No Objection</u> <u>Certificate</u>" mandatorily submitted at the time of interview. Otherwise their candidature shall not be considered for selection and extension of time for submission of <u>N.O.C.</u> shall not be granted.
