

1. A stipend to GNM students of IGIMS shall be given from the academic session 2022-2025, in accordance with the norms, rules, and regulations of the Government of Bihar. The stipend shall be Rs. 1,500 per month.
2. In case of unauthorized absence, the proportionate stipend shall be deducted for that period as per the applicable rules.
